# EX MIN 19/132 EX MEM 19/61 WATER CORPORATION OF ANGUILLA (WCA) REQUEST FOR REFINANCING THE STORAGE TANK THROUGH A LOW INTEREST LOAN

Hon Parliamentary Secretary, Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained.

# Council agreed that:

- (i) the WCA should exercise the buyout in accordance with section (5) subsection (5.2.2) as stated below for ease of reference:
  - "5.2.2 WCA shall have the option to purchase the plant and/or the tank from the Company after completion of the first twelve months after the commencement date of this agreement and at any other time thereafter during the term of this agreement at the price as set forth in the schedule contained herein".
- (ii) the WCA borrows the funds required from the Social Security Board to finance the buyout at a rate not exceeding 8% per annum, which will guarantee minimum savings of US\$281,000 over three years relative to the initial arrangement; and
- (iii) the WCA be allowed to be committed to the loan for a period not exceeding thirty-six months and the said land that is being held by Scotia Bank be released and provided as security for the loan from the Social Security Board.

Council recognised that this transaction represents debt as did the initial transaction. Council noted that the UKG must be made aware that this approval is seeking to regularise the situation that was initially presented to the UKG in 2011.
