#### EX MIN 20/455 **CONFIRMATION OF THE MINUTES**

Hon Parliamentary Secretary for Economic Development, Hon Special Ministerial Assistant to the Hon Minister for Social Development/ Education and Financial Specialist remained.

Council confirmed the Minutes of the 17<sup>th</sup> Meeting of Executive Council held on Thursday 5<sup>th</sup> November 2020.

#### MATTERS ARISING FROM THE MINUTES

Council noted that:

- the Comptroller of Inland Revenue continues to work on the report on the reform of the Interim Stabilization Levy and will provide financial information to the Hon Minister for Finance;
- in relation to the appointment of a Supply Officer the Attorney General's Chambers has provided a clear direction, accordingly the Hon Deputy Governor will work to appoint a Supply Officer promptly. It is essential that Council is able to receive a report on the work of the Supply Officer;
- 3) the Statutory Bodies continue to submit quarterly reports and the work is progressing well, although some inconsistencies must be addressed. There is a standard template to be used for the preparation of 2021 quarterly financial reports and onwards;
- 4) a dedicated team of four persons are processing applications of returning residents made via the portal; and
- as it relates to the arrival fees collected under the Quarantine Act which should be directly credited to the Consolidated Fund. Amendments to the Regulations may be required to facilitate hotels remitting the arrival fees to the Government of Anguilla on behalf of guests. The Hon AG will take this forward.

# EX MEM 20/222 EXECUTIVE COUNCIL APPROVAL TO AMEND EX MIN 20/400 - PAGE 5 RELEVANT SECTION

Hon Parliamentary Secretary for Economic Development, Hon Special Ministerial Assistant to the Hon Minister for Social Development/ Education and Financial Specialist remained.

Council noted the Ministry's request to amend EX MIN 20/400 given the provisions of Part 3 Section 16 of the Anguilla Air and Sea Ports Authority Act R.S.A C. A57 and the clear intention that AASPA must not undertake any activities for which it does not have the requisite resources.

Following discussion Council:

1) agreed that EX MIN 20/400 in relation to AASPA should be amended to read as follows: -

"i. AASPA – the Hon Minister MICUH&T shall engage with the Chairman of the Board to:

- ensure the Board approves and implements as a matter of urgency the actions identified to reduce contingent liabilities;
- b) direct the AASPA Board to cease all activity related to arrangements that may be interpreted as Public Private Partnerships (PPPs) and Novel Financing Arrangements linked in any way to development of all ports including CJLIA, unless the conditions of sections 24 and 25 of Schedule 1 of the Fiscal Responsibility Act are met;
- c) the Government of Anguilla considers that AASPA can: (a) only take actions to advance the development of ports for which it has the financial resources to fund itself; and (b) given the long-term financial implications of major redevelopments the Government of Anguilla will lead on these matters if there is a need to enter into PPPs or novel financing arrangements;
- d) the AASPA Board must immediately write to all parties with whom it had consultancy contractual arrangements. This includes parties which the consultant contractors engaged with on behalf of AASPA or the Government of Anguilla to inform them that:
  - (i) the contractual relationship with the consultant contractor has ended;
  - (ii) the consultant contractor no longer acts on behalf of either AASPA or the Government of Anguilla;
  - (iii) neither AASPA nor the Government of Anguilla will be pursuing activity originating from those relationships; and
  - (iv) if the same or similar activities are progressed

in the future this will be through a new independent and open tender process;

- e) the Hon Attorney General will opine on the best way to proceed as it relates to the KCI Consultancy contract success fee"; and
- 2) instructed the Attorney General's Chambers to draft a template letter for i). d). above to ensure that AASPA is acting within the appropriate legal parameters given the situation.
