### EX MEM 21/60 APPROVAL OF THE PUBLIC UTILITIES COMMISSION (PUC) BUDGET 2021

The Hon Minister for MICUHT briefed Council. The board of the Public Utilities Commission has approved its budget which was amended in accordance with Ex Min 20/510. The PUC does not require any subvention from the Government of Anguilla.

### EX MIN 21/114 COVID-19 & ASTRAZENECA/OXFORD VACCINE UPDATE

### **Vaccination Deployment Update**

The second batch of AstraZeneca Covid-19 vaccines, a total of 4,000 doses, were received by the Government of Anguilla via air courier on March 17, 2021 at 5:00 pm. Anguilla has received to date 12,000 doses of the vaccine.

As of March 17 at 4.00 pm, there were 6281 persons registered of which 5,248 persons have received their first dose. This represents 42% of the target population figure of 12,600 persons. The breakdown by occupation is as follows:

- 252 Healthcare workers
- 311 Civil, border protection and port staff
- 1006 Hospitality workers

- 742 Retired
- 2937 Others

Using 2011 census age demographics, the breakdown of individuals who have received the vaccine by age, is as follows:

- 1566 persons age 18 34 (32% of target)
- 1851 persons age 35 49 (40 % of target)
- 1781 persons age 50 64 (62 % of target)
- 1041 persons age 65+ (67% of target)

This indicates that vaccination uptake is lower among the younger age groups. The Health team will continue outreach and promotional efforts directed towards groups where vaccination uptake is not as high as desired (18 - 45 year olds and hospitality workers) and provide more options for vaccination in the community. This week a second vaccination site was opened in South Hill, and arrangements are also being made to provide vaccinations at the Hughes Medical Centre.

The Health team has partnered with Digicel to offer mobile vaccination sites in Island Harbour and at Best Buy East, starting on Saturday 20<sup>th</sup> March, 2021.

The telecoms companies are disseminating agreed promotional texts. IWAS will also collaborate with the Ministry of Health and host a mixer for social media influencers and other young persons on Friday 26<sup>th</sup> March. Outreach in the community continues.

### **Exit Planning Update**

The formulation of the Covid-19 exit planning strategy continues, with input from other sectors at this stage.

### Council:

 noted that both the first and second batch of vaccines received have an expiration date of May 2021. A continuous supply of the vaccine is not guaranteed;

- 2) noted that the 12,000 doses of vaccine received are sufficient to provide the second dose required for all persons who have already received one dose, and to provide some additional vaccinations thereafter;
- noted that an updated breakdown of vaccination uptake by District would be beneficial; and
- 4) further noted that prolonged closure of Anguilla's borders is not sustainable and that the measures taken to control the importation and transmission of COVID-19, that is all existing COVID-19 related Regulations, will have to be reduced and then eventually come to an end. By April 1, the Ministry of Health anticipates being in a position to announce the proposed timeline for relaxation and removal of the COVID-19 measures.
