- (i) the Government of Anguilla should make a formal commitment to the signing of the Memorandum of Understanding (MoU) with the UKG regarding the funding of Aviation Safety Regulations or issuing a letter of intent to sign the MoU by December 20, 2011 following formal consultation with the stakeholders;
- (ii). a request for formal commitment with timeframes from the UKG to provide technical assistance to the Government of Anguilla in the areas listed below:-
- (a) the assistance offered in the area of offshore aircraft registry needs to be more robust and meaningful in that GoA really needs a full report on the institutional and legislative requirements for the establishment of an offshore aircraft registry and Directorate of Civil Aviation including a financial and economic assessment;

- (b) in addition to the UKG assisting GoA in identifying a more sustainable means of funding Aviation Safety Regulations, GoA should also request assistance in determining the impact of the increase fees on the aviation industry;
- (c) GoA should also request technical assistance for the development of a Strategic Aviation Master Plan for Anguilla's medium and long term development of aviation facilities, infrastructure, terminal building, air strip and related services. This will build on the recommendations pertaining to aviation and the airport in the Sustainable Tourism Master Plan.

- (iv) directed the Ministry of Finance to develop the necessary protocols to ensure that Anguilla is able to meet its international commitments with respect to information exchange and make the administrative arrangements necessary to implement that protocol;
- (v) agreed to designate the Compliance Officer within the Ministry of Finance to implement the policy and ensure that the protocol is in place;
- (vi) agreed that representatives from Anguilla participate in training on TIEA implementation which is being organized in Montserrat early in 2012.

EX MIN 11/800 <u>INF 11/07 COUNCIL REGULATION 359/2011</u>

Council was made aware that in April 2011 the Foreign Affairs Council of the European Union agreed to place restrictive measures on certain persons complicit in or responsible for directing or implementing grave human rights violations in the repression of persons in Iran who speak up in defence of their legitimate rights, including freedom of expression. They also agreed restrictive measures on persons complicit in or responsible for directing or implementing grave violations of the right of due process, torture, cruel, inhuman and degrading treatment, or the indiscriminate, excessive and increasing application of the death penalty, including public executions, stoning, hangings or executions of juvenile offenders in contravention of Iran's international human rights obligations. These measures were implemented by Council Regulation (EU) No. 359/2011 adopted on 12th April 2011which came into force on 14th April 2011, the date of its publication.

Council noted that FCO Legal Advisers have prepared an Order in Council to implement these restrictive measures in the Overseas Territories, including Anguilla. The draft Order has been provided to the Attorney General's Chambers for their consideration. The FCO will look to bring the Order into force as soon as possible after the consultation period has elapsed.
