- (ii) the amendment be made retroactive as of 1 January 2001;

### EX MIN 11/892 <u>EX MEM 11/389 WATER CORPORATION OF ANGUILLA 2012</u> ANNUAL BUSINESS PLAN

Mr Larry Franklin, PS, MICUH and Mr Rommel Hughes, CEO, Water Corporation joined the Meeting.

Council approved the 2012 Annual Business Plan for the Water Corporation of Anguilla along with the following amendments and additions:-

- (i) Water Corporation of Anguilla (WCA) to include in the plan the critical success factors for the achievements of the targets in the Annual Business Plan;
- (ii) WCA to develop and include a service charter in the Business Plan. There is a need to demonstrate and benchmark the level of service offered by the Water Corporation. Also a need for a greater focus on the level of customer service;
- (iii) There is a need for a much more aggressive/urgent approach to address the issue of NRW with an aim to reduce it to an acceptable level of below 25% (the World Bank recommends that NRW should be "less than 25%") within the next 3 5 years;
- (iv) There is an urgent need to benchmark and address the inefficiencies in the operations of the Water Corporation of Anguilla;
- (v) The marketing section should have more focus on the traditional 4Ps of Marketing namely, price, promotion, place and product;
- (vi) The Government of Anguilla to consider a proposal for an additional rate structure for institutions like small hotels;
- (vii) The WCA needs to place a dollar value on NRW and consider different scenarios as to how the level of NRW could be reduced and how the overall profitability of the WCA will be affected. This should eventually translate to a reduction in water rates to the customers;

- (viii) The WCA needs to devise formal procedure to address debt collection in an effort to reconnect customers who have been disconnected. One suggestion is to forgive part of the debt for example 25 50% to encourage customers to get reconnected thereby widening the customer base;
- (ix) Other than a subdivision of the rate structure, the GoA/Minister MICUH should not approve any request for increasing water rates. The WCA should focus on loss reduction and increasing efficiency to increase financial viability.

Council agreed that in lieu of permitting an increase to the water tariff, the GoA will commit to meeting the cost of the electricity fuel surcharge.

#### Accounts and Audit – Amendments and Additions

- (i) WCA to appoint auditors by February 1, 2011
- (ii) WCA should prepare accounts on a cash basis using International Public Sector Accounting Standards (IPSAS) for the years 2009, 2010 and 2011
- (iii) Starting financial year 2012, the WCA will prepare its accounts on an accrual accounting basis using International Financial Reporting Standards (IFRS)
- (iv) The auditors will be informed of how the accounts will be treated for 2009, 2010 and 2011.
- (v) GoA and WCA need to complete the transitional arrangements as outlined in Part 6 of the Water Corporation of Anguilla Act.
