EX MEM 12/100 ABOLISHING METAL RECYCLING OPERATIONS

Council agreed to an urgent review of the licensing system of the metal recycling business. To this effect, Council agreed the following press release:-

This statement is issued on behalf of EXCO following its meeting on 12 April:

"Executive Council discussed on 12 April the recent spate of thefts of metal and metal products in Anguilla.

EXCO has decided to institute an immediate moratorium on the export of scrap metal and urgently to review the metal re-cycling business in Anguilla. It has tasked the Ministry of Finance, together with the RAPF and the Customs Dept, to report to EXCO on 19 April on how best to curb the illegal export of metal which may be contributing to the spate of thefts. In particular, EXCO intends to:

(1) Review the arrangements for licensing metal re-cycling businesses, including establishing the number of licences already issued;

- (2) Consider how best to deal with any illegal metal re-cycling operations on the island;
- (3) Review the procedures for exporting scrap metal, including storage before export, to ensure that Customs are able to observe the packing and to seal all containers and thereby ensure that no illegally acquired metal is included in any shipment."
