EX MIN 12/254 EX MEM 12/108 FURTHER AMENDMENTS TO EDUCATION BILL 2012

Council agreed that:-

- a) under Revised s. 25: Home Education, sub-section (5) should read:- "A student in a home education programme may attend courses offered by the Ministry of Education, subject to any terms and conditions established by the regulations.
- b) sub-section (7) (a) make provision for the assessment of the student's achievement on a termly basis and communicate the results to the parent. ("termly" may need to be defined).

The full text of the amendment to the Education Bill in relation to home schooling is as follows:-

In the Interpretation section:

"home education programme" means a course of study provided to a student under the direction of the student's parent and centred in the student's home or, subject to sections 25(5) and 25(6), somewhere other than an educational institution;

Revised s. 25:

Home education

- 25. (1) A parent of a student may provide a home education programme for the student if the parent complies with this section and if the programme meets the goals and objectives set out in section 3(3).
- (2) The parent shall:-
- (a) before the commencement of a home education programme for the student; and
- (b) on an annual basis, after such commencement, for as long as the home education programme is offered,
- (c) register the student with the Chief Education Officer.
- (3) An educational plan for each student in a home education programme shall be prepared and provided to the Chief Education Officer subject to the following conditions:-
- (a) the initial educational plan shall be prepared and provided to the Chief Education Officer not later than 3 months before the commencement of the home education programme;
- (b) the educational plan shall be for a minimum period of 3 academic years and shall cover every year of the home education programme;
- (c) the educational plan shall include a description of the learning activities for the student that will comply with the goals and objectives set out in section 3(3); and

- (d) the educational plan shall be compatible with the national curriculum established under Part 8.
- (4) The parent of a student in a home education programme may request that tests be administered to the student subject to the requirements of the regulations and to payment of fees prescribed for any tests that are administered.
- (5) A student in a home education programme may attend courses offered by the Ministry of Education subject to any terms and conditions established by the regulations.
- (6) Subject to regulations made under this Act, the parent of a student in a home education programme may receive, for the student, educational resource materials and approval for the use of school facilities and equipment.
- (7) For the purposes of this Division, the Chief Education Officer shall:-
- (a) make provision for the assessment of the student's achievement on a termly basis and communicate the results to the parent;
- (b) provide the necessary advice to the parent if, in the opinion of the Chief Education Officer, the student is not making reasonable progress in the programme; and
- (c) provide the parent with recommendations which will assist the student in improving the level of achievement.

- (ii) To establish three Tourism Working Groups;
- (iii) To establish an oversight team for the tourism Working Groups;
- (iv) To establish an inter-ministerial committee on the environment;
- (v) In principle to establish a Legal and Security Advisory Group.

Council further agreed that:-

- a) The three Tourism Working Groups will operate in the East End, West End, Central Tourism Development Areas. The working groups will be comprised of technicians in the public service, members of the private sector and members of the respective communities. The groups will be guided by the following Terms of Reference:-
- (i) To play an advocacy role in promoting the STMP and its initiatives in general and in the tourism development areas in particular;
- (ii) To develop a database of sites, attractions and tourism assets in the tourism development areas;
- (iii) To develop a database of resources (technical, human, and financial) to facilitate the enhancement and promotion of these assets;
- (iv) To assist in implementing projects aimed at enhancing tourism assets in the tourism development areas for the benefit of nationals and residents of Anguilla to be shared freely with the visiting public;
- (v) To assist in monitoring and management of the tourism assets during the enhancement phase and beyond.
- b) An oversight team comprising of leading bodies such as the Anguilla Tourism Board, Anguilla Hotel and Tourism Association, Anguilla Chamber Of Commerce and Industry, The National Trust. The Anguilla National Creative Arts Association, Anguilla Archaelogical and Historical Society and the Ministry of FEDICT, will provide guidance on the use and management of Anguilla's heritage and tourism assets, within the Tourism Development Areas.
- c) An inter-ministerial committee on the environment comprising the Department of Environment, the Anguilla National Trust, the Department of Disaster Management, the Department of Physical Planning, the Water Laboratory, the Department of Infrastructure, the Department of Lands and Surveys, the Department of Fisheries and Marine Resources and the Ministry of FEDICT. This committee was established as a consequence of a number of cross cutting environmental issues related to Tourism Development in general and the Tourism Development Areas in particular.
- d) Agreed in principle to a Legal and Security Advisory Group to consider and address the legislative framework for tourism. This will be comprised of representatives of the office of the Attorney General, The Ministry of FEDICT, the Anguilla Tourist Board, the Royal Anguilla Police Force, an appointed member of the Bar Association, The Chief Immigration Officer and Comptroller of Customs.
- e) Other resource persons will be co-opted as necessary to these Tourism Development Area working groups, the Legal and Security Advisory Group and the Inter-ministerial Committee on the environment. These

groups will provide intelligence, guidance and specialist technical skills, which will auger well for the sustainability of the tourism initiatives.
