Council:-

(i) agreed the most appropriate wording to address the concerns by the Hon Evan M. Gumbs as follows:-

Section 25(3)(d) – "the educational plan shall be compatible with the National Curriculum established under Part 8";

(ii) agreed that the section referring to 'Home Schooling' should be worded to make it clear that 'Home Schooling' does not mean that a child or children is/are confined physically to the house.

Council further agreed the following amendments to the Bill as outlined in the paper:-

Sections 143 and 144 have been replaced by the following:

Abolition of corporal punishment

143. (1) No person who:-

- (a) is employed at or in respect of a school; or
- (b) owns, manages or controls an assisted private school, a private educational institution or an early childhood education facility,

shall administer corporal punishment to any student or child enrolled at or attending the school, institution or facility.

(2) No person who, on behalf of a school, is supervising or controlling any student or child enrolled at or attending such school shall administer corporal punishment to the student or child.

Interpretation of section 143

144. (1) Subject to subsection (2), references in section 143 to administering corporal punishment to a student or child are to doing anything that involves the application of physical force to punish or correct the student or child, whether or not there are also other reasons for so doing.

For the purposes of section 143, a person shall not be considered as administering corporal punishment by virtue of anything done for that include averting an immediate danger of personal injury immediate danger to the property of, any person, including child concerned.

Section 70 is amended as follows:

Prohibition of discrimination

- **70.** Without prejudice to any other law, a private educational institution which denies admission to a child or expels a child on account of:-
- (a) race, colour, religion, place of origin of the child; or
- (b) race, colour, religion, place of origin or political affiliation of any parent of the child,commits an offence and is liable on summary conviction to a fine of \$3,000.

- the Hon Minister, Education should communicate with the public regarding the amendments to the Bill;
- b) the Bill should be gazetted and that a date for the reading of the Bill in the House of Assembly will be determined by the House.
