- 2) agreed to the publication of an official statement of condolence from the Government and people of Anguilla on the passing of this revolutionary hero;
- 3) agreed that flags should be flown at half-mast on the day preceding the funeral and until dusk on the day of the funeral;
- 4) agreed that a Police Guard of Honour should be drawn up at the church and a contingent of uniformed officers should bear the body in and out of the church and at the graveside. The casket should be covered with the national flag;
- 5) agreed to a contribution of EC\$8,000 towards the cost of the funeral expenses;
- 6) agreed that a Policy should be developed to guide Government in the official recognition of Anguilla's revolutionary heroes and heroines and other prominent Anguillians when they die.
