PS, FIN indicated to Council that all the technical issues with regard to the FFSD had been settled and the only remaining issue was the language with respect to the Review Clause. He stated that following the teleconference on Tuesday 2nd April with FCO and relevant officials that the FCO had indicated that the language in the framework should be retained and will be addressed when the legislation is being drafted.

The Hon CM reiterated that his concern was the delayed assent to the 2013 Budget. HE The Governor pointed out that the signing of the FFSD today would determine how soon the 2013 Budget would be assented to. The CM went on to say that he was willing to sign the FFSD today, provided that the Budget is signed simultaneously.

Ministers of Government requested a separate discussion with FEDICT Officials on the matter. Other members of Executive Council absented themselves from the EXCO Chamber and EXCO adjourned.

On the resumption of the EXCO meeting, the Hon CM announced that he would be signing the FFSD on Friday 5th April 2013 at 9:00 am in the presence of the Press.

Council agreed that the relevant officials will have further discussions with FCO via teleconference on Friday 5th April at 9:30 am on the 2013 Budget.
