EX MIN 13/251 **CONFIRMATION OF THE MINUTES**

Council confirmed the Minutes of the 146th Meeting held on Thursday 4th April 2013.

Council agreed that EX MIN 13/240 of 4th April 2013 should be amended in part as follows:-

(i) agreed to allow businesses that manufacture on island a concession on the importation of any plant, machinery and raw materials to be used in the manufacturing business for a period up to ten (10) years from the date at which the business starts up (in the case of manufacturing businesses that are already operational; from the date which they notify the Ministry of Finance, Commerce and Economic Development that they want to exploit this opportunity).

EX MIN 13/256 ORAL STATEMENT BY GOVERNOR ON CONDUCT OF FORMER MINISTER FOR HOME AFFAIRS

"I should like to make a short statement about the conduct of the former Minister for Home Affairs, Hon Walcott Richardson.

I began to have concerns about Mr Richardson's conduct over work permits soon after he took office. Later on, I became concerned about his extensive use of visa waivers. This practice stopped when I intervened and ensured that public officers only recognised/honoured visas which were issued in accordance with the established policy. But my concerns about work permits, a matter on which I could not intervene without the Chief Minister's co-operation, remained and intensified throughout his period as a Minister. I repeatedly expressed those concerns to the Chief Minister, who is ultimately responsible for the conduct of Ministers, and asked him to agree to an independent inquiry, or to suggest some

other way of dealing with them. As Mr Richardson has now left office, there is no value in actively pursuing these concerns any further. But for the record I want to set them out to Executive Council.

I first raised my concerns with the Chief Minister on 23 September 2010. At the time, they related to the relatively narrow issue of Mr Richardson turning down work permit applications without consulting Executive Council. Over the next few months I obtained evidence of other possible abuses, and set them out in a letter to the Chief Minister, at his request, on 13 January 2011. The concerns could be summarised as follows:

- Turning down work permits without consulting EXCO;
- Issuing work permits for a shorter period than applied for without consulting EXCO;
- Delaying considering work permit applications for an unreasonable time, often at cost to the applicants;
- Seeking to persuade employers to employ friends and supporters, using the issue of work permits as leverage;
- Seeking to persuade employers to dismiss people, using similar leverage;
- Seeking to persuade employers to grant contracts to particular persons, using similar leverage;
- Granting a work permit to the client of a supporter before the application was lodged, thus preventing appropriate due diligence by the Labour Department/Ministry;
- Granting work permits in return for favours.

I repeatedly asked the Chief Minister over several months to agree to an independent inquiry. I pointed out that, if Mr Richardson was not guilty of the misconduct alleged, an inquiry would be the simplest way to clear his name. I hoped that the Chief Minister would agree to an inquiry in light of his oft repeated commitment to maintaining the highest standards in his administration. But he refused to do so. I later asked him to propose an alternative way forward but he did not do that either. It follows that my concerns remain unallayed, and I believe that in refusing to address them no effort was made to promote the operation of the principles of good governance in Anguilla and thereby promote the interests and wellbeing of the people of Anguilla".

Council confirmed the decision taken by round robin on 8th April 2013 that Mr Blessed Ziggy Henry, a national of St. Kitts to be employed by Ms Loureen Webster as a Caregiver should be exempted from the work permit requirement in accordance with Section 3 (1) g of the Control of Employment Act.

Council noted that the vacant position was advertised and that no other applications were submitted to the Labour Department to fill the vacancy.

However, it was brought to the attention of Executive Council that this matter had a history behind it and may not be a genuine case. Council agreed, subject to asking the Labour Commissioner and the Chief Immigration Officer to clarify their concerns, that the exemption permit not be immediately issued.
