- (ii) noted that, on 21st March 2014, EXCO agreed to make available the resources to facilitate the drafting of the Foreign Account Tax Compliance Act (United States of America) (Implementation and Enforcement of Inter-Governmental Agreement) Bill 2014. The bill is the overarching legislation to explicitly provide for the collection of FATCA-relevant information and for that information to be passed on to Inland Revenue for transmission to the U.S. Authorities; and
- (iii) noted that the United States has indicated that the main text of the IGA is not open for substantive negotiation;
- (iv) noted that implementing and administering FATCA requirements, including Inland Revenue's obligations set out in the IGA, will have significant impacts on Inland Revenue who will become the intermediary for data transfer between Anguillian financial institutions and the United States' Internal Revenue Service (IRS);
- (v) authorised the Chief Minister and Minister of Finance to sign the FATCA IGA on behalf of the Government of Anguilla, once the text was been vetted and formatted by the AG's Chambers;
- (vi) endeavoured to pass the Foreign Account Tax Compliance Act (United States of America) (Implementation and Enforcement of Inter-Governmental Agreement)
 Bill 2014 into law as soon as practical;
- (vii) agreed that the Ministry of Finance issue a press statement announcing that Anguilla has formally concluded negotiations with the U.S. re FATCA.
