EX MIN 18/185 **CONFIRMATION OF THE MINUTES**

Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained in attendance.

Council confirmed the Minutes of the 136^{th} Meeting held on Thursday 5 April 2018.

EX MIN 18/187 <u>EX MEM 18/107 PERMANENT RESIDENCY BY INVESTMENT</u> (ECONOMIC RESIDENCY)

Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained in attendance. Mr Larry Franklin, PS, EDICTIT and Mrs Shantelle Richardson, Director of Economic Planning joined.

With reference to EX MIN 18/182 of 5 April 2018, Council:-

- (i) approved the updated draft Permanent Residency Policy that incorporates Permanent Residency by Investment;
- (ii) agreed to a soft launch regularising persons who meet the criteria based on prior investment;
- (iii) agreed that the Ministry should submit a budget to Executive Council for consideration; and
- (iv) agreed that the technical team, Attorney General's Chambers and Financial Specialist should convene to work out other aspects of the policy as it related to the development of legislation.

Following consideration of the Criminal Justice Reform legislation, Council agreed that the Criminal Justice Reform Act should be amended as follows:-

- Part 6, Amendments to the Drugs (Prevention of Misuse) Act, "Schedule 4" (Sections 7 (1) & (2)) page 39:-
 - (a) Cannabis weight changed from 7 grams to 10 grams
- 2) Amendments to the Vehicles and Road Traffic Act page 34:-
 - (a) to ensure that child safety seat provisions come into force one year after the Act comes into force.

During further discussion, the Hon Minister of Home Affairs expressed her objection to automatic paper preliminary inquiries. The AG and the Minister would have

further discussion on this matter.

EX MIN 18/191 EX MEM 18/111 EXPULSION ORDER – GARVEY CUTHBERT SHILLINGFORD

Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained in attendance.

Council:-

- (i) noted that Mr Garvey Cuthbert Shillingford, an alien from Dominica was sentenced to prison on 16 March 2015 for handling stolen goods contrary to section 274 of the Criminal Code, Revised Statutes of Anguilla chapter C140 and sentenced to two (2) years in prison;
- (ii) noted that on 16 October 2015 Mr Shillingford was sentenced to prison for sexual intercourse with a person between 14 and 16 years of age contrary to section 145(1) of the Criminal Code, Revised Statutes of Anguilla chapter C140 and sentenced to three (3) years in prison;
- (iii) noted that on 28 March 2018, by virtue of the powers vested in the Governor under section 2 of the Undesirable Persons, Expulsion Act, R.S.A., c. U5, Mr Timothy J Foy, OBE, Governor, appointed Pastor Phillip Gumbs to hear any reasons to be urged by Garvey Cuthbert Shillingford as to why an expulsion order should not be made against him; and
- (iv) additionally noted that on 3 April 2018, Pastor Gumbs visited Her Majesty's Prison and conducted the hearing with Mr Shillingford. Pastor Gumbs has submitted a report which indicates that Mr Shillingford has an objection to returning to his homeland. He has indicated that he has no one to return to in Dominica and that he has been in Anguilla since the age of 9. He further indicated that if he returns to Dominica, he would not have a social support network.

Council requested the following information before taking a decision on the matter:-

- 1) submission of the report from Pastor Phillip Gumbs
- 2) age of Mr Shillingford
- 3) status in Anguilla (whether a belonger/naturalised person)
- 4) marital status (if married, is it to an Anguillian)
- 5) whether he has children
- 5) was he employed and at what establishment
- 6) how often has a non-belonger/alien been expelled from Anguilla using the Undesirable Person's legislation

eighteen months before the elections. The DG added that the main focus was the Boundaries Act to be followed by the Election Act.

EX MIN 18/194 DIVESTMENT OF ANGLEC SHARES - REGULATORY FRAMEWORK

Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained in attendance.

Council:-

- (i) noted that Executive Council directed that the regulatory framework for the electricity sector be addressed prior to the divestment of the shares of ANGLEC;
- (ii) noted that the time frame for completion of the divestment of the shares is June 2018;
- (iii) further noted that there was need to use the most direct and shortest procurement mechanism to revise the regulatory framework for the electricity sector; and
- (iv) agreed that MICUH should make the case to the procurement officials to engage a suitably qualified and experienced consultant to advance the revision of the regulatory framework for the electricity sector as quickly as possible so that the divestment of the shares could be undertaken by the June 2018 timeline.
