## EX MIN 18/292 EX MEM 18/155 DESIGNATING ANGUILLA STRONGER AS A CHARITABLE ORGANISATION (TEMPORARY)

Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained in attendance.

Council:-

- (i) agreed in principle to grant the charitable status to Anguilla Stronger for an approved period and extend the exemption for Anguilla Stronger until 30 September 2018;
- (ii) agreed in principle that Customs should facilitate a refund of the reconciled amount of duty paid by Anguilla Stronger and its related accounts; and
- (iii) agreed that the Comptroller of Customs should liaise with the Hon Attorney General to give effect to (i) and (ii).

The Governor noted the very significant financial consequences of this decision. The financial position was very tight and the loss of revenue associated with this decision would inevitably carry consequences for many ordinary Anguillans in terms of the education and health services. He requested the Hon Deputy Governor to ensure that a protocol covering the type, nature and duration of any exemptions in the period following a hurricane is clearly and quickly established with Customs.
