The Financial Specialist remained in attendance.

Following on from EX MIN 18/424 of 16 August, and EX MIN 18/439 of 24 August the DG and the CM noted that the meeting between the Ministers and Permanent Secretaries regarding the Workplan for 2018 and medium term legislatives priorities was useful. They agreed that those pieces of legislation that were ready for parliament would proceed at the earliest opportunity.

It was also agreed that legislation or amendments related to finance and economic development, particularly those in support of the MTEFP, would be prioritized. The DG further noted that there were several pieces of legislation that were listed but had no EXCO approval, drafting instructions, nor policy guidance. In such cases, the relevant Permanent Secretary will brief the relevant Minister in order to make a determination on the way forward.

The DG noted that implementing the Workplan for 2018 will form the basis for his and the Permanent Secretaries performance objectives for the rest of the year.

# EX MEM 18/222 APPOINTMENT OF RENT COMMISSIONERS

Financial Specialist remained in attendance. Ms Ivenia Benjamin, Senior Magistrate joined.

Council:-

(i) noted that the Rent Restriction Act of Anguilla R.S.A c R50 states at section 3 that:

- (1) "The Governor in Council may for the purpose of carrying into effect the provisions of this Act appoint 3 fit and proper persons, one of whom shall be a government officer to be a Rent Commissioner for Anguilla".
- (2) "The Governor in Council shall appoint one of such persons to be Chairman of the Rent Commission".
- (ii) noted that pursuant to the said provisions of the Rent Restriction Act, a cadre of eleven (11) persons have been trained to serve on the newly instituted Rent Court/Tribunal in Anguilla. The said Commissioners participated in a three-day training workshop from 15 17 August, 2018. The Rent Court/Tribunal at any sitting constitutes of a Chairman along with two rent Commissioners for the purpose of hearing and disposing of disputes between landlords and tenants;
- (iii) further noted that to avoid putting too much pressure on the same Commissioners, a panel of eleven (11) persons were trained, from which two will be selected for every sitting;
- (iv) agreed that the following should be appointment to serve as Rent Commissioners:

- (vii) further agreed that a formal paper with the amendments should be brought to Executive Council for consideration.

# INF 18/05 INFORMATION NOTE:- NATIONAL FUNERAL FOR THE LATE MR. COLLINS J. CARTY IN RECOGNITION OF HIS INVALUABLE CONTRIBUTION TO ANGUILLA DURING THE REVOLUTION

Financial Specialist remained in attendance.

Council noted the passing of Mr. Collins J. Carty of Rey Hill on Friday  $24^{\rm th}$  August 2018.

His personal testimony might never be told, but the events surrounding his involvement in the Anguilla Revolution are well chronicled in Petty and Hodge's book, "Anguilla's Battle for Freedom, 1967 – 1969."

As a young man, just twenty years old, Collins was among the men who ensured that the St. Kitts policemen were carted off the Wallblake Airport onto a flight back to St. Kitts on May 30, 1967. He was one of two men who guarded the plane to ensure that the policemen did not disembark.

Petty and Hodge in the book detailed the plot to overthrow the ruling government in St. Kitts in 1967. It was on the afternoon of June 9th, 1967 when the sloop *'The Rambler'* owned by James Ronald Webster of Island Harbour set sail for St. Kitts with 18 men on board including Collins to execute the plan.

Collins along with four others were captured and arrested by the St. Kitts police on suspicion of their involvement in the failed coup d'état. It would take some four months before the case could be heard. On October 26, 1967, Collins was the first man to be tried. On the announcement of a non-guilty verdict, Collins was immediately flown home to his beloved country where he was greeted by a large and appreciative crowd.

The late Collins J. Carty was awarded with the Anguilla Badge of Honour and Certificate in 2016 for his outstanding contribution to the Anguilla Revolution.

In keeping with EX MIN 14/612 (vii) and EX MIN 15/535, the Ministry of Home Affairs has therefore begun the process of making arrangements which will include:

- (i) the holding of a National Funeral for the late Collins J. Carty in collaboration with the family; the date of the funeral is to be announced;
- (ii) the publication of an official Statement of Condolence from the Government and people of Anguilla on the passing of this revolutionary hero;
- (iii) flags to be flown at Half Mast on the day preceding the funeral and on the day of the funeral;
- (iv) a Police Guard of Honour to be drawn up at the Church and a contingent of uniformed officers to bear the body in and out of the church and at the graveside. Casket to be covered with the national flag; and
- (v) a contribution of EC\$5,000 towards the cost of the funeral expenses and EC\$3,000 towards the other expenses.
