- APPLICATION FOR ISSUE OF LICENCE UNDER THE ALIENS LAND
HOLDING REGULATIONS ACT – DOLPHIN DISCOVERY ANGUILLA
LIMITED – REGISTRATION SECTION WEST CENTRAL, BLOCK 28309 B,
PARCEL 169 (LEASE PART OF) CONTAINING 1.45 ACRES

- (b) to comply with the Labour Department Act R.S.A. c. L15 and Section 16 (1) and (2) of the Fair Labour Standards Act, R.S.A. c. F15;
- (c) the area to be leased is 1.45 acres of land being Lot 1 as delineated on Survey Plan LS11-18;
- (d) to pay rent per annum in the amount of US\$22,000.00/EC\$59,140.40 increasing by 2% per annum;
- (e) a rent free period of one (1) year;

- (f) stamp duty to be paid in two (2) installments, upon which the lease would be registered;
- (g) the terms of the lease is 99 years, commencing 15 October 2018 and that the Government of Anguilla has favourably considered that the Company would have the first rights of refusal if Crown decides to divest of its interest in the property;
- (h) the Ministry of Lands to write to the Company notifying of the approval;
- the licence to use the Sea Floor under the Beach Control Act be prorated for 2018 by Inland Revenue Department to commence from 14 August 2018; and
- (j) the Licensee undertakes to develop the property within thirty-six (36) months of the date of the issue of the Licence, failing which a penalty of US\$3,500.00 shall apply for each calendar month or part thereof that the project remains uncompleted. Following the said period of thirty-six (36) months, the said penalty shall not preclude the Government of Anguilla in any way from exercising its right to commence forfeiture proceedings.

If said dwelling house is not completed at the end of thirty (30) months, 50% of the refundable deposit would be forfeited to the Government of Anguilla. The balance 50% would be forfeited if the construction is not completed within a further six (6) months. Thereafter, forfeiture proceedings for the property would be commenced by the Government of Anguilla for a period of twenty-four (24) months; and
- (c) with the expressed condition that the land is to be used for residential purposes and that the Licencees must not rent their dwelling house without first notifying the Ministry of Lands.
