### MATTERS ARISING FROM THE MINUTES

EX MIN 18/486 EX MIN 18/475 FAMILIARIZATION VISIT BY ATTORNEY GENERAL DESIGNATE

Parliamentary Secretary and Ministerial Assistant to the Hon Minister, MHA remained.

Following on from EX MIN 18/475 of 13 September, the Hon Deputy Governor noted that the familiarization visit by the Attorney General Designate went well. He further noted that his contract with the GoA is signed and housing secured. The DG added that the AG Designate was briefed on the GoA's workplan and legislative calendar, and is looking forward to formally assuming his role on 1 October 2018.

#### EX MIN 18/487 EX MIN 18/477 UPDATE ON 2020 GENERAL ELECTIONS

Parliamentary Secretary and Ministerial Assistant to the Hon Minister, MHA remained.

Following on from EX MIN 18/477 of 13 September, Council noted that the revised draft of the Elections Act and opinion from the Attorney General's Chambers would be sent to the PS, MHA for perusal. Council emphasised the importance of progressing the legislation and its expectation that the draft bill would be presented for Council to consider at its next meeting.

## EX MIN 18/488 EX MEM 17/286 EXTENSION TO CONDITIONS FOR REPAYMENT OF DEFERRED SALARY PROPOSAL RE HURRICANE IRMA

Parliamentary Secretary and Ministerial Assistant to the Hon Minister, MHA remained.

Following a thorough discussion, Council agreed that:

- (i) an amendment be made immediately to the existing policy to include:
  - (a) education purposes: specifically persons who can show that they are experiencing financial difficulty in supporting children already in education; and
  - (b) persons who can show they are at risk of a lender foreclosing on a loan in respect of their homes.
- (ii) at the end of September following an assessment of government's overall financial position the GoA will make a policy statement noting its commitment to make some payment against these arrears before the end of 2018; and
- (iii) a determination be made as to the precise extent of any such payment in November 2018 when there is further clarity on the revenue position and a judgment can be made about paying these arrears against other priorities.

Council noted the repeated requests by the Hon Minister, HSD that HAA should be able to position their deferred salaries like GoA. Council reiterated that there was no procedural impediment to HAA paying arrears, the issue was their financial position which largely reflected GOA's outstanding arrears to the HAA. Prompt payment of these arrears would assist HAA in paying deferred salaries to HAA staff. Council agreed that the PS, FIN, PS, HLPP and the CEO, HAA need to work on this matter.

### EX MIN 18/489 EX MEM 18/239 FIRST ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING BETWEEN GOVERNMENT OF ANGUILLA (THE "GOVERNMENT") AND PARKSTONE INCORPORATED (THE "DEVELOPER")

Parliamentary Secretary and Ministerial Assistant to the Hon Minister, MHA remained. The following persons joined:

Council noted the draft addendum to the MoU between Parkstone Incorporated and the Government of Anguilla. HE The Governor pointed out the importance of revitalizing this section of the real estate market, and that he recognized the importance of treating all developers equally. Consequently he noted that this issue should not be considered as a "concession" to an individual developer but rather as a sector wide policy to boost the economy. Council agreed that the PS, EDICTIT should prepare a clear-cut uniform policy to this effect to be agreed by Council as soon as possible.

## EX MIN 18/490 EX MEM 18/240 APPEAL AGAINST PLANNING REFUSAL APPLICATION REF#: 17/0160 (GOBLINS RETREATS LLC)

Hon Parliamentary Secretary, Ministerial Assistant to the Hon Minister, MHA, Financial Specialist, PS, EDICTIT, Compliance Officer and DLS remained.

The Hon Minister, MHA declared an interest and absented herself from discussion.

Council agreed that the appeal against planning permission for Goblins Retreat LLC should be allowed on the following grounds:

- (i) the development as proposed would have the adequate setbacks to meet current standards;
- (ii) the development would still be tourism in nature albeit in a different form: a more exclusive residence development on Lot #2 and a villa/apartment development on Lot #1 with at least a six (6) bedroom unit to be developed;
- (iii) the changing nature of the global economy necessitates that developers/ investors continually modify investments in keeping with demand;

- (iv) the company, Goblins Retreats LLC must sign off on revised supplementary conditions to the Licence Agreement with the Government of Anguilla in order to reflect the changes in the development (i.e. a residence on Lot 2 and Villa on Lot 1), and agree to make any other amendments to their ALHL that may be necessary to effect this subdivision and have the new parcels registered in the company's name; and
- (v) the Department of Lands and Surveys should also monitor the progress of this development to ensure that all components remain as part of the tourism plant of Anguilla and not for private residential use.
