EX MIN 18/597 **EX MEM 18/290 REFUSAL TO GRANT WORK PERMITS**

Hon Parliamentary Secretary and Financial Specialist remained.

In keeping with Section 4 (1) of the Control of Employment Act, the Hon Minister of Home Affairs and Immigration consulted with Executive Council on the refusal to grant work permits. Council considered and endorsed the recommendation from the Minister that thirteen (13) persons should not be granted work permits.

Council noted that the refusals are based on the grounds that:

- (a) there are suitably qualified belongers of Anguilla who can do the work;
- (b) the wages proposed to be paid for the positions are such that it is likely that these persons would be unable to sustain themselves in Anguilla or will have to seek additional work (which is prohibited for persons already in possession of a work permit); and
- based on the cost to sustain a livelihood in Anguilla, most of these persons will fall below the poverty line (approximately EC\$16,348 per annum) or the vulnerability (i.e. at risk of being poor if there is any external shock) line (approximately EC\$20,484 per annum) which will put an additional strain on social services.

Council further noted the Minister's intention to withdraw one name for further information.

EX MEM 18/291 APPOINTMENT/RE-APPOINTMENT OF THE MEMBERS TO THE BOARD OF THE WATER CORPORATION OF ANGUILLA
