### EX MIN 11/776 EX MEM 11/324 DUTY EXEMPTION FOR MAYOUMBA FOLKLORIC THEATRE

Dr Wycliffe Fahie, PAS, FIN joined the Meeting.

Council agreed that duty exemption should be granted to the Mayoumba Folkloric Theatre (c/o Mr Calvert Carty) on a mixer board, speakers and microphones on the grounds that the group remains at the forefront of the promotion and continuation of important elements of Anguilla's culture.
