Further to EX MIN 13/317 of 2nd May 2013, HE The Governor made the following statement regarding the above:-

"I indicated at Executive Council on 2 May that I intended to rule under Section 28 (2) (e) of the Constitution that the decision to amend the previous EXCO decision on the re-structuring of the AG's chambers would cause material prejudice to Her Majesty's service and that I therefore did not intend to follow EXCO's advice as I am normally bound to do. I also indicated that I would explore further options before the minutes, and hence the EXCO decision, were confirmed.

I have decided on reflection and after discussion not to have recourse to the relevant sub-section of the Constitution. I continue to believe that use of this section would be justified to ensure the integrity of the appointment of individual public service officers. But I also fully accept that it is for the elected Ministers to make decisions on financial issues. I have noted the assurances given during EXCO discussion that the proposal was put forward by the Chief Minister as a financial matter, aimed at saving public money, and not directed at a particular individual."
