Addenda Issue Date: July 3, 2014

**Bid Closing Date and Time**: The bid closing date is July 25, 2014 at 12 noon.

**Purpose**: The purpose of this Addendum is to make changes, additions, deletions, revisions and clarifications to the bid documents dated May 20, 2014 for the project referenced above. Bidders shall review the Addenda and requirements in detail and incorporate any effects the Addendum may have on their bid price.

**Acknowledgement**: Bidders must acknowledge receipt of any and all Addenda. All requirements of the bid documents remain unchanged except as cited herein.

The following revisions have been made to **SCHEDULE D - SPECIFICATIONS/SCOPE OF SERVICES.** 

1. Item 6 (1). HOURS OF SERVICE page 4 of 16. The paragraph should now read:

### 6. HOURS OF SERVICE

- (1) Except as otherwise provided herein, SOLID WASTE collections at the premises of GENERATORS shall not start before **4.00 a.m.** and should have disposed of all waste **by 3.00 p.m.**, unless the permission of the AUTHORIZED PERSON is sought in advance by the CONTRACTOR'S REPRESENTATIVE, and permission is given. The hours of service are subject to change by the Authorized Officer.
- 2. Item 7 (2). HOLIDAYS page 4 OF 16. The paragraph should now read:
  - 2) No collection will be made on Christmas Day or New Year's Day, Easter Monday, Labour Day, Anguilla Day, Whit Monday, August Monday, August Thursday but those days must be made up before or after the holidays.
- 3. The following words CLINICAL WASTE have been deleted from Item 8 (1). ZONES OF OPERATION page 5 of 16. The paragraph should now read:

### 8. ZONES OF OPERATION

1. The ZONE OF OPERATION for the SERVICES to be provided under this CONTRACT is defined in Attachment 1. The CONTRACTOR shall be fully responsible for the removal of all SOLID WASTE from all DOMESTIC premises and GOVERNMENTAL INSTITUTIONS except BULKY WASTE, GARDEN WASTE, HAZARDOUS WASTE, CONSTRUCTION or DEMOLITION DEBRIS.

**4.** The following additions have been made to Paragraph 9 (14) – SERVICES AND EQUIPMENT - Schedule D – SPECIFICATIONS/SCOPE OF SERVICES page 6 of 16.

# 9 (14) - SERVICES AND EQUIPMENT

- (14) Where there are festivals in the Contractor Zone of Operation the CONTRACTOR shall be responsible for providing sufficient WASTE BINS and the removal of SOLID WASTE generated.
- 5. The following additions have been made to Paragraph 9 (15) and (16) SERVICES AND EQUIPMENT Schedule D SPECIFICATIONS/SCOPE OF SERVICES page 6 of 16.

# 9 (15) - SERVICES AND EQUIPMENT

(15) Where there are generators of CLINICAL WASTE in the Contractor Zone of Operation the CONTRACTOR shall place identifiable WASTE BINS for its collection.

# 9 (16) - SERVICES AND EQUIPMENT

(16) Where there are generators of waste from vessels (aircrafts or ships) in the Contractor Zone of Operation the CONTRACTOR shall place sufficient WASTE BINS for its collection.
