#### A BILL FOR

#### 2016 APPROPRIATION ACT, 2015

[Gazette Dated: 30<sup>th</sup> November, 2015] [Commencement: Assent under section 57 of the Constitution]

An Act to provide for the services of the Government of Anguilla for the financial year ending the 31<sup>st</sup> day of December, 2016.

#### ENACTED by the Legislature of Anguilla

#### Citation and Commencement

1. This Bill may be cited as the 2016 Appropriation Bill, 2015 and shall come into operation on the 1st day of January 2016.

#### Appropriation

2. There shall be and there is hereby granted to Her Majesty, the Queen, for and towards defraying the several charges and expenses for the services of the Government of Anguilla, for the year ending the thirty-first day of December 2016, the sum of two hundred and twenty eight million, nine hundred and four thousand, six hundred and sixteen dollars (EC\$228,904,616) to be applied and expended in the manner and for the services set forth in the schedule to this Bill.

#### Sums charged on Consolidated Fund

**3.** The sum of two hundred and twenty eight million, nine hundred and four thousand, six hundred and sixteen dollars (EC\$228,904,616) shall be and the same is hereby declared to be charged upon and made payable from and out of the Consolidated Fund of Anguilla.

#### **Authority to Pay**

**4.** The Accountant General of Anguilla is hereby authorized and required from time to time upon the

Authority of a Warrant, under the hand of the Minister of Finance, to pay the several sums appropriated by and in the Schedule to this Bill to the several services herein mentioned as the said Warrant shall direct out of the Consolidated Fund of Anguilla without further order or formality.
