APPROPRIATION (2018) ACT, 2018

AN ACT to provide for the services of the Government of Anguilla for the financial year ending the 31st day of December, 2018.

ENACTED by the Legislature of Anguilla

Citation and Commencement

1. This Act may be cited as the Appropriation (2018) Act, 2018 and shall be taken to have come into operation on the 1st day of January, 2018.

Appropriation

2. There shall be and there is hereby granted to Her Majesty, the Queen for and towards defraying the several charges and expenses for the services of the Government of Anguilla, for the year ending the 31st day of December, 2018 the sum of **two hundred and eighty seven million, nine hundred and one thousand, nine hundred and sixteen dollars** (\$287,901, 916) to be applied and expended in the manner and for the services set forth in the schedule to this Bill.

Sums charged on Consolidated Fund

3. The sum of **two hundred and eighty seven million, nine hundred and one thousand, nine hundred and sixteen dollars** (\$287,901, 916) shall be and the same is hereby declared to be charged upon and made payable from and out of the Consolidated Fund of Anguilla.

Authority to Pay

4. The Accountant General of Anguilla is hereby authorized and required from time to time upon the Authority of a warrant, under the hand of the Minister of Finance, to pay the several sums appropriated as specified in the Schedule to this Bill to the several services herein

mentioned as the said warrant shall direct out of the Consolidated Fund of Anguilla without further order or formality.
