- i) As requested by the Hon. Member for Valley North the Hon. Speaker allowed condolences and well wishes to be given by Members who wished to do so and requested that they speak to gun violence and offer suggestions as to what can be done as a community to mitigate such.
- ii) Hon. Speaker then opened the floor for contributions and the following Members offered greetings and condolences to those who mourn:
  - Hon. Deputy Governor expressed thanks on behalf of his family and himself to all Members on the presentations given on the passing of his brother.
  - Hon Member for SIWED, Mr. Kenneth extended condolences to the families of the Late Earnest Crawford and the Late Tony Fleming and urged the Anguillian community to return to the time of true community values looking out for one another and being our brother's keeper.
  - Hon. Member for Road South welcomed back the Hon. Deputy Governor and offered condolences to all those who mourn including Members of the House. Leave was also requested and granted to read a post of one of the daughters of the Late Earnest Crawford (with her consent).
  - Hon. Member for SIWED, Mrs. Quincia Gumbs-Marie also extended condolences to all who mourn the passing of persons throughout the entire year, in particular this month whether naturally or tragically. Persons were urged to speak up to make a change and look within ourselves first while being an encouragement to others. It was suggested that the RAPF and Courts put greater effort into educating the community of the consequences to such negative acts.
  - Hon. Member for SIWED, Mr. José Vanterpool welcomed the Hon. Deputy Governor and offered condolences to all who mourn urging the public to put the guns down. It was suggested that we sit and reflect on where we are today thinking about the future we want to see for Anguilla.
  - Hon. Member for Valley North extended condolences to those who lost loved ones, in particular the family of the Late Earnest Crawford. It was suggested that a Committee be put in place from the House to address the gun violence and offered to be a member of the said Committee once it is established.
  - Hon. Member for SIWED, Mr. Kyle Hodge extended condolences to the Spanish community on the passing of the Late Tony Fleming. The public was urged to be actively involved in our communities spending quality time with the members. New Year's greetings were also extended to all including the staff under his Ministry.
  - Hon. Member for Road North extended condolences to all who mourn at this time and as it relates to the issue of gun violence it was suggested that action is needed now and welcomed the idea of a special Committee being put into place. New Year's greetings were also extended to all.
  - Hon. Member for West End extended condolences to the families of the Late Tony Fleming and Earnest Crawford. It was also recommended that as we go into the New Year that our commitment going forward needs to be community oriented.

- Hon. Member for Island Harbour thanked everyone for the presentations given and also offered condolences to all who mourn, in particular the families of the Late Earnest Crawford, Janice Morton-Connor and Kareem Bradley. Several suggestions in relation to the issue of gun violence were given including holding Seminars on gun violence addressing conflict avoidance and de-escalation measures, etc. An appeal was made for all eligible persons to get vaccinated. A special thanks was expressed to those in both the Ministry of Health and the Ministry of Finance and New Year's greetings were also extended to all.
- Hon. Speaker agreed to take up the suggestion offered by the Hon. Member for Valley North to establish a Committee to address gun violence and will allow it to be tabled at another Sitting. Additionally, Members of the House and public were invited to offer suggestions to remedy the issue of gun violence.
